



VOLUNTEER WAIVER AND LIABILITY RELEASE (FOR MINORS) & CONSENT BY PARENT/LEGAL GUARDIAN

I, _____, the parent or legal guardian for

_____ (hereinafter referred to as the "Minor"), hereby consent to and authorize the Minor to act as a volunteer of The Christian Herald Association d/b/a The Bowery Mission (collectively hereinafter referred to as "The Bowery Mission"). I acknowledge and agree that any and all activities performed by the Minor as a volunteer (hereinafter referred to as the "Minor Volunteer Activities") will be performed strictly on a voluntary basis, without any pay, compensation, or benefits. I agree and understand that the Minor must comply with the verbal and/or written instructions, rules and regulations established by The Bowery Mission, and that failure to do so, may result in the Minor's immediate removal as a volunteer.

I am aware of the nature of the Minor Volunteer Activities and recognize that in performing the Minor Volunteer Activities, known, unknown and unanticipated risks of harm and/or injury(ies) exist. I agree that the Minor Volunteer Activities are performed by the Minor at the Minor's risk. I hereby expressly assume any and all risks, known or unknown, that exist in and arise from the Minor's participation in the Minor Volunteer Activities at The Bowery Mission.

I understand that I am completely, solely and one-hundred percent responsible for the whereabouts and supervision of the Minor at all times during his or her participation in the Minor Volunteer Activities. I also expressly understand that neither The Bowery Mission nor any of The Bowery Mission's officers, employees, partners, affiliates, agents, representatives, volunteers and/or any other persons or entities acting in any capacity on behalf of The Bowery Mission (collectively hereinafter referred to as "The Bowery Mission Reps") is responsible for the whereabouts or supervision of the Minor during the Minor's participation in the Minor Volunteer Activities.

I also expressly assume the risk of any theft, loss or damage to the Minor's personal property that may occur while the Minor is engaged or performing the Minor Volunteer Activities. I expressly waive, discharge, and release The Bowery Mission and The Bowery Mission Reps from any claims, suits, demands, damages, causes of action, losses and expenses related to such theft, loss or damage. I also agree that I am solely and fully responsible for any personal or property damage the Minor causes in the course of the Minor's participation in the Minor Volunteer Activities.

On behalf of myself, the Minor, and our respective heirs and personal representatives, I agree to, release, indemnify, discharge and hold free and harmless The Bowery Mission and The Bowery Mission Reps from and against all claims, suits, demands, damages, causes of action, losses and expenses, including attorney fees, that are in any way connected to or related to the Minor's participation in the Minor Volunteer Activities.

If the Minor has a medical, mental or physical condition that could interfere with the Minor's safety while participating in the Minor Volunteer Activities, I hereby assume and bear the costs and



responsibility of all damages, risks or injuries that may be created, directly or indirectly, by any such condition. If the Minor is injured or becomes ill and neither I nor any other parent/guardian identified below can be reached, I give The Bowery Mission and The Bowery Mission Reps permission to seek medical attention for the Minor.

I understand that the Minor may be photographed during the course of the Minor's volunteer efforts. I grant full and unlimited permission to The Bowery Mission and The Bowery Mission Reps to use the Minor's name, photographs or any other record of the Minor's participation in the Volunteer Activities in any broadcast, telecast, cable cast, multimedia productions, Internet distribution, closed circuit exhibition, illustration, promotional purposes, print distribution, and/or any other account of my participation in the Activities for publicity purposes, without compensation, and in perpetuity throughout the world. I hereby release The Bowery Mission and The Bowery Mission Reps from any and all claims based on the Minor's name, likeness, image, biographical material and/or voice or use of recordings of such.

I hereby acknowledge that I am the parent, legal guardian, or person otherwise legally responsible for the Minor and have complete authority to consent to and authorize the Minor to act as a volunteer for The Bowery Mission as contemplated herein.

I have carefully read this entire document and fully understand its contents. I have had sufficient opportunity to read this entire document. I am aware that this is a release of liability and waiver of my right to bring a lawsuit, claims, charges, demands and/or causes of actions on the basis of any claim for which I have herein released The Bowery Mission and The Bowery Mission Reps.
